# Dolphin beach application form

« DANGER NOTICE and CONFIRMATIONS »

The following is a list of hazards and precautions that you may be exposed to while participating in our program. Please read the following information carefully, check the box for confirmation, and sign or affix your seal at the end if you agree to the terms and conditions.

If a small child is unable to understand, please make sure that the accompanying person understands the following items before participating in the tour.

## Check

1. This program does not use bait for the dolphins. The dolphins may not come close to you depending on their condition. Please understand that no refunds will be made in such cases.

2. Please follow the instructions of the instructor and our staff. If you do not follow the instructions of the staff, you will be held responsible for any accidents that occur.

The organizer may not be responsible for any accidents that occur as a result, and you may be asked to pay for any damages.

3. Participation in Dolphin Beach may result in drowning, broken bones, bruises, and injuries.

Dolphins may engage in playful behavior such as biting, kicking (body contact), poking, etc. Please be sure to follow the instructions of the staff during the program and be very careful of the dolphins' behavior yourself. Please be aware that the organizer will not be held responsible for any damage caused by the dolphins' behavior.

4. In order to avoid the above-mentioned dangers, the staff will always explain the precautions before entering the water. Please listen carefully to the explanation, ask questions if you have any questions, and make sure you understand everything before entering the water.

5. The cove is a natural cove, and the stairs leading down to the cove and inside the cove can be slippery. Also, stones, rocks, shells, and other creatures (jellyfish, sea urchins, ferns, etc.) may cause injuries. Please be careful during the program.

6. Please wear the prescribed attire such as swimsuits or body boots. Please remove jewelry and fake nails in advance and put everything in your pockets in your locker to avoid accidental ingestion or injury to the dolphins. Please cut long fingernails short before participating in the tour.

7. If a customer does not follow the instructions of the staff and causes damage to the dolphins, drops something into the water that may lead to accidental ingestion by the dolphins, or engages in any behavior that the dolphins do not like (holding, pulling, holding, etc.), the program will be cancelled at the discretion of the staff. If the dolphins are harmed or the aquarium facilities are damaged as a result of such behavior, the dolphins will be subject to claims for compensation for damages.

8. Cameras and cell phones are not allowed in the aquarium, even if they are waterproof.

9. Persons under the influence of alcohol are not allowed to participate in the tour.

10. We ask that chaperones keep an eye on your children and make sure that they follow the above rules. Please be aware that the chaperone may be required to hold the child in his/her arms at all times depending on the situation. Please be aware that if a child does not follow the instructions of the staff, the program may be cancelled at the discretion of the staff.

11. Minors must have the consent of a person with parental authority to participate in the program. Please sign in writing in the signature box below.

12. In the event of an accident during the tour, regardless of the reason, the liability of "Max Co. Max Co., Ltd. will be held responsible for any accidents that occur during the tour, regardless of the reason, within the limits of the insurance policy that Max Co. The parties agree that any disputes shall be handled under the following terms and conditions. The court with jurisdiction over the location of Max Co.
