《DANGER NOTICE and CONFIRMATIONS》

The following is a list of precautions to be taken when participating in our program. Some of them include a description of the dangers that may occur to you. Please read the following information carefully, check the box for confirmation, and sign or seal the end of the form if you agree to the terms.

If a small child is unable to understand, please make sure that the accompanying person understands the following items before participating.

Check

□ 1. This program does not use bait for the dolphins. The program will be held under natural conditions, so depending on the condition of the dolphins, they may not approach you. Please understand that no refunds will be made in such cases.

 \Box 2.Please follow the instructions of the instructor and our staff. The organizer may not be responsible for any accidents that occur as a result of your failure to follow the instructions of the staff, and you may be asked to pay for any damages.

 \Box 3. If there are children who do not follow the instructions of the staff, the program may be cancelled at the discretion of the staff.

□ 4. If a customer does not follow the staff's instructions and harms the dolphins, drops something in the water that may lead to accidental ingestion by the dolphins, or engages in any other behavior that the dolphins do not like (holding, pulling, holding, etc.), the program will be cancelled at the discretion of the staff. If the dolphins are harmed or the aquarium facilities are damaged as a result of such behavior, the dolphins will be subject to claims for compensation.

□ 5. Those who have been drinking, are pregnant, have a disability or mental illness, or are currently taking medication are not permitted to attend. In addition, we may not be able to accept those who have health problems, so please inform us in advance if you have any concerns. Please inform us in advance if you are concerned about your health.

□ 6. participation in dolphin snorkeling/floating dolphin may result in drowning, broken bones, bruises, injuries, etc. Dolphins may engage in playful behavior such as biting, kicking (body contact), poking, etc. Please be sure to follow the instructions of the staff during the program and be very careful of the dolphins' behavior yourself. Please be aware that the organizers will not be held responsible for any harm caused to you by the dolphins' behavior.

 \Box 7. In order to avoid the above-mentioned dangers, the staff will always explain the precautions before entering the water. Please listen carefully to the explanation, ask questions if you have any questions, and make sure you understand everything before participating in the tour.

8. Since we are using a natural cove, the stairs leading down to the cove and inside the cove may be slippery.
Also, stones, rocks, shells, and other creatures (jellyfish, sea urchins, ferns, etc.) may cause injuries.
Please be careful during the program.

□ 9. Please wear the prescribed attire and equipment specified by the organizer. Please remove jewelry and fake nails in advance and place everything in your pockets in a locker to prevent accidental ingestion or injury to the dolphins. Please cut long nails short before participating in the tour. □ 10. You are allowed to bring your own waterproof camera, video camera, or cell phone, but there is a possibility that it may be damaged or flooded due to the dolphins' behavior. In such cases, we will not be able to compensate for any damage to the equipment or data. Please bring at your own risk. To prevent accidental ingestion by dolphins, please wear the device with a strap or the like so that it will not fall off even when your hands are removed from the device.

□ 11. In the event of an accident during the tour, regardless of the reason, the organizer (Max Co., Ltd.) agrees that the extent of its liability shall be handled within the scope of the insurance coverage it has in place, even if the company is at fault (however, this does not apply if the company is grossly at fault). The organizer agrees to submit to the exclusive jurisdiction of the court having jurisdiction over the location of its head office in the event of any disputes.

□ 12. Minors must have the consent of a person with parental authority to participate in the event. Please sign the signature line below in your own handwriting.

*We will not provide or disclose the information you provide to any third party without your prior consent, except to contact you in case of emergency or to provide information to medical institutions in case of emergency.
